The Town of Osoyoos will inform affected properties by mail with a Boil Water Notice within the last two weeks of March. Should you NOT receive a Boil Water Notice, you have now been

connected to the **Domestic Water** Service.

Should you still be serviced by the Agricultural Irrigation System 8 or 9, please ensure that you are adhering to the following recommendations:

Water intended for drinking. washing ready-to-eat fruits and vegetables, making beverages or ice, or brushing teeth should be boiled for one minute.



Please notify tenants, visitors, or other building occupants of the boil water notice.

EARLY/LATE IRRIGATION APPLICATION

Unless otherwise advertised* the regular irrigation season runs annually from April 15 to September 30.

Application and Fees are to be processed at Town Hall.

- Early Water from April 3 to April 14*
- Late Water from October 1 to October 31*

Anyone who does not abide by Bylaw No. 1357 could be liable to a fine of up to \$2,000 for each offence.

WATER DISTRICT BYLAW 1357

Please refer to Schedule "F" of the Osoyoos Water District Rates and Regulations Bylaw No. 1357.04 for more information.

Sprinkling is only permitted at residential, commercial, and other non-agricultural properties as follows:

Even numbered addresses: Watering is only permitted on Saturday, Tuesday, and Thursday

Odd numbered addresses: Watering is only permitted on Sunday, Wednesday, and Friday

The following are exempt from restrictions:

- · Watering of public sports playing fields, turf farms, and golf courses;
- Watering of flower and vegetable gardens, decorative planters, shrubs, and trees using micro-irrigation, drip-irrigation, or a hose with an automatic shut-off nozzle;
- Commercial car washes so long as each vehicle wash does not exceed 57 L of water.
- Under authority of permit issued (by the Town of Osoyoos) under this bylaw.



Do routine inspections.

Periodically check your sprinklers to make sure everything is working properly.

FLOW CONTROL VALVE PROGRAM

- The Town of Osoyoos allows 8.25 US Gallons/per minute/per acre.
- The Town of Osoyoos currently has a Flow Control Testing Program to ensure the proper amount of flow to each orchard or vineyard.

The Town of Osoyoos has the right to test any flow control valve at any time.

INVOICE/BILL PAYMENTS

Utility Water bills are issued annually. Payments are to be received by August 15, 2023 @ 4:30pm.

Payments can also be made through your financial institution by Phone or the Internet.

- Amounts outstanding after August 15 will be subject to a 10% penalty.
- After December 31, 2023, any outstanding amounts will be subject to an additional 10% penalty and deemed to be in arrears with respect to the property.
- Effective January 10, 2024, the unpaid balance is then transferred, as utilities in arrears, to the property tax roll maintained by the Province.

It is the owner's responsibility to notify the Town in writing when any changes or modifications are made to the premises that may affect water utility rates.

The Town of Osoyoos must be notified of any mailing address changes/updates.

DISCOLOURED WATER

You may be experiencing discolored water due to the increased water usage that occurs in the spring, don't be alarmed.

- Run a cold faucet (preferably an outside tap) for about 10-15 minutes or until the water is clear
- Do not use a hot water tap, as doing so may draw sediment into your hot water tank.
- Do not choose a faucet with a water filter connected to it, as sediment may clog the filter.
- Please refer to "Boil Water Notice" section.
