## Property Tax Pre-Authorized (Monthly) Payment Plan



**YOU DO NOT NEED TO REAPPLY FOR PRE-AUTHORIZED PAYMENT EACH YEAR UNLESS YOUR INFORMATION HAS CHANGED. THIS FORM IS FOR NEXT YEAR'S TAXES.**

### TERMS AND CONDITIONS

1. Property taxes for the **CURRENT YEAR must be paid in full** before joining the plan.
2. Prepayments are calculated for 10 months from August to May with a final balance withdraw deducted on June 25<sup>th</sup>. There are no payments in July.
  - o Deductions from your bank account will be made once a month, on or after the fourteenth (14<sup>th</sup>) of each month.
3. The monthly payment is an **ESTIMATE** only, and not a warranty or guarantee of the amount of taxes which may be levied.
  - o The estimate is based on 1/10 of your last year's taxes after applying the Northern and Rural (N & R) Home Owner Grant (if applicable) with a 10% increase.
4. It is the owner's responsibility to **claim the N & R Home Owner Grant** if applicable.
5. The current charge of \$20.00 for dishonored payments will apply.
6. Simple interest will be paid on your prepayments at the quarterly rate set by the Province.
7. Once your prepayment has been calculated, you will be sent a copy of the calculated amount.
8. Pre-Authorized payment is a service provided by the Town of Osoyoos free of charge, however, your bank may charge you depending on the type of account you have.
9. Payments attached to your property tax account remain attached to the account and cannot be withdrawn.
  - o If you sell your property your lawyer must determine the amount of money prepaid and credit you accordingly in the sale documents.
10. If you wish to cancel your pre-authorized payments and/or if you sell your property, written notice of cancellation or a signed payment plan form requesting cancellation is required by the last day of the month or prior to the date of the sale.
11. Any tax accounts with a credit balance after the due date will be carried forward and deducted from the upcoming years calculation.
