## **PUBLIC HEARING**

## Short-Term Rental (STR) Regulation Review

A public hearing is being held with respect to a proposed Official Community Plan (OCP) and Zoning Bylaw amendments related to the Short-Term Rental (STR) Regulation Review.

**Amendment Bylaw No. 1375.07, 2025**, proposes to introduce new policies relating to "short-term rental accommodations" to the Town of Osoyoos OCP Bylaw No. 1375, 2021.

**Amendment Bylaw No. 1395.04, 2025**, proposes to amend the Town of Osoyoos Zoning Bylaw No. 1395, 2024, by introducing new Specific Use Regulations and off-street vehicle parking requirements with respect to "short-term rental accommodation" uses, and adding "short-term rental accommodation" as a permitted accessory use in the Small-Scale Multi-Unit Residential (RS1) and Agriculture (AG) Zones.

The purpose of the proposed amendments is to implement a new Short-Term Rental Pilot Program.

In accordance with Section 466 of the Local Government Act, the public hearing will be conducted in a hybrid fashion in-person and by video conference (i.e., Zoom), as follows:
